



### The rules below define conditions of the contest “10<sup>th</sup> Tarnów Jazz Contest 2017”

1. The contest is organized by Tarnowskie Stowarzyszenie Artystyczne *Artcontest* located at 49 Wilsona Street, 33-100 Tarnów, entered into the National Court Register under number 0000357654, hereinafter referred to as the organizer.
2. The contest will take place in two categories:
  - band (for bands)
  - soloists (for individual performers)
3. The contest will be divided into 2 age categories:
  - a. junior -for people up to 21 years of age, mostly for Music School (level II) students who are not enrolled in higher education courses.
  - b. open – no age limits
4. The contest entails a music performance in front of the jury. The program must comprise obligatory part and, depending on the category, a free of choice standard. Both parts are described in the attachment number 1.
5. The organizers will introduce a lottery system to decide the order of participants to perform.
6. The jury, appointed by the Organizer, will oversee the contest.
7. After a short deliberation, the jury will give its opinion on the presentation.
8. The jury will evaluate each performance based on the artistic value, arrangement as well as composition and style accuracy. The jury will grant extra points to participants for interesting compositions of their own, as well as arrangements of obligatory standards, for example in a different style or mood, or in an altered metric.
9. Rhythm sections (b, dr) are not allowed to perform in two different bands.
10. In the solo category, the soloists will be accompanied by a professional rhythm section provided by the Organizer

11. The finalists will be given awards. Each contestant will receive a certificate. The winners who get awards are required to give their personal details including their home addresses and pay appropriate taxes.
12. The entrance to all the workshops and concerts during the festival is free for the participants of the contest.
13. Jury may award the most outstanding band or soloist the Grand Prix TIJC prize. The jury may decide not to award the Grand Prix prize. These decisions are final and made after hearing all the performances.
14. Application form, which can be downloaded from the festival official website at [www.tarnow-jazz.pl](http://www.tarnow-jazz.pl) must be sent by October 26<sup>th</sup> 2017 to the following address via mail: ArtContes, ul. Wilsona 49, 33-100 Tarnów, Poland with an annotation 'Jazz', or via email to [jazz.contest@gmail.com](mailto:jazz.contest@gmail.com). Together with the application form a photo and a short description of a band must be enclosed.
15. The participants under the age of 18 can take part in the contest as long as they provide their parents' permission in writing. The application form should include the permission.
16. The participants will qualify to take part in the contest by providing the application form on time on a 'first come, first served' basis. The organizers may change the list of the qualified participants before the beginning of the contest.
17. The complete list of bands and soloists that qualified to enter the contest will be available on the festival website [www.tarnow-jazz.pl](http://www.tarnow-jazz.pl) by October 30<sup>th</sup> 2017. The bands or the soloists will be informed in e-mails if they qualified.
18. Admission fee is 25 EURO per entrant and must be sent to the bank account number of Stowarzyszenie ArtContest 63 1240 5194 1111 0010 4815 1280 by November 2<sup>nd</sup> 2017 and a copy of a payment receipt must be enclosed. Admission fee will not be returned in a case of participant's resignation.
19. In the case of not paying the admission fee, the participant will be excluded from the list of the contest performers.
20. The Participants agree to be filmed during the contest.
21. The participants give the organizers the right to use their pieces of music free of charge, all over the world as well as their music presentations and artistic performances as a whole and in parts in order to promote the festival
  - a. in reproduction and fusing the music – making and reproduction by

using specified techniques copies of musical works by means of a specific technique, including printing, reprography, magnetic recording and digital technique as well as reproduction in computer systems.

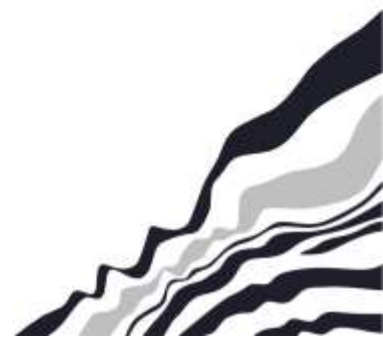
- b. trading in the original or copies on which the works covered by the license were recorded - the introduction into circulation, allowing use or rental of the original or copies
  - c. distribution in a different way than stated above – public performance, display, presentation, reproducing and broadcasting as well as rebroadcasting, in addition sharing the musical works publicly as well as making the work available to the public in such manner that everybody could have access to, including the web.
22. Participants of the Competition also grant their permission for unpaid use of their image and music performed during the contest in promotion and marketing of the contest and to the publishing of his/her name, surname and the name of the band.
23. The winner will be awarded with financing of professional recording and releasing an album with the recordings of the band or the soloist, however, the performer is entitled to put the logo of the organizer on the CD cover. The organizer decides about the form and size of the logo.
24. The organizers reserve the right to the final interpretation of these regulations.
25. The organizers provide participants with 1 guitar amplifier, 1 bass amplifier, basic drum set, a grand piano and stage piano. Drummers should be equipped with their own snare drums and a set of cymbals.
26. The costs of travel, accommodation, food and others will be covered by participants themselves or an organization which delegates them.
27. The organizer is identified as controller for the personal data. All personal information on participants shall be processed by the organizer according to the Personal Data Protection Act of 29 August 1997 permitted only for conducting the competition, communications with the participants, giving awards, settling current tax liabilities with the awards. Competition Participants have the right to access their data and correct it as well as delete it.

Attachment no 1- the competition procedure

**The team category-Junior**

1. The competition in the team category in a junior age group consists of one stage.
2. Each band is required to perform an obligatory work of music and a free choice piece of music.
3. The participants are required to perform:
  1. Obligatory part: a piece by Dizzy Gillespie, Thelonious Monk or Buddy Rich (own choice)
  2. Own choice of music
4. The performance must not exceed 15 minutes
5. The award winners will be selected by the Jury after all presentations are performed.

**The soloist category-Junior**

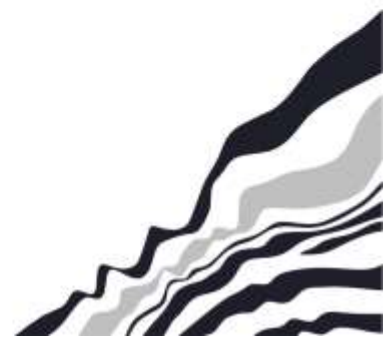
1. The contest in the soloist category in the junior age group consists of two parts; semi-finals and finals.
2. Participants qualified to the Contest will be supported by rhythm section and will perform a music presentation. The presentation will involve two elements of the obligatory program listed below.
3. Based on the performances, the Jury will select the finalists who will perform a music presentation, and may be accompanied by members of the Jury. The presentation will involve a selected element of the obligatory part. The Jury decides on the number of finalists.
4. The obligatory program:
  1. Semi-finals: A piece by Dizzy Gillespie, Thelonious Monk or Buddy Rich
  2. Final: Blue Monk-Thelonious Monk
5. The finalists will be chosen by the Jury after presentations.
6. The performance must not exceed 15 minutes

**The team category-open**

1. The competition in the team category in the open age group consists of one stage.
2. Each band is required to perform an obligatory work of music and a free choice piece of music. All presentation must be performed from memory.
3. The participants are required to perform:
  1. Obligatory part: a piece by Dizzy Gillespie, Thelonious Monk or Buddy Rich
  2. Own choice of music
4. The finalists will be chosen by the Jury after presentations. The performance must not exceed 20 minutes

**The soloist category-open**

1. The contest in the soloist category in the open age group consists of two parts; semi-finals and finals.

2. Participants qualified to the Contest will be supported by rhythm section and will perform a music presentation. The presentation will involve two elements of the obligatory program listed below.
3. All presentations must be performed from memory.
4. Based on the performances, the Jury will select the finalists who will perform a music presentation, and may be accompanied by members of the Jury. The presentation will involve a selected element of the obligatory part. The Jury decides on the number of finalists.
5. The obligatory program:
  1. Semi-finals: A piece by Ella Fitzgerald, Dizzy Gillespie, Thelonious Monk, Buddy Rich and own choice of music
  2. Final: Indiana-James F. Hanley
6. The performance must not exceed 20 minutes
7. The finalists will be chosen by the Jury after presentations.

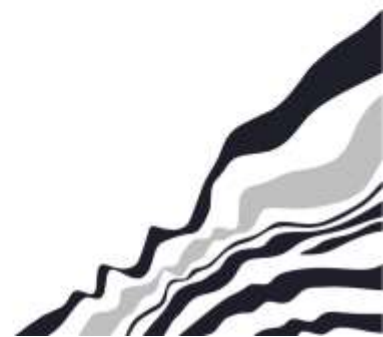

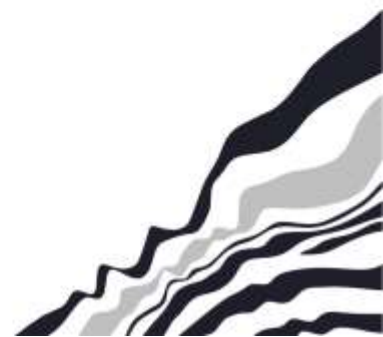
